

CIVIL COMPLAINT

Purpose: This form is used to initiate a court action to seek relief in non-criminal matters.

How: The plaintiff or their advocate prepares a civil complaint that contains:

- a. A short and plain statement of the grounds upon which the court has jurisdiction to hear this case, unless the court already has jurisdiction to support the claim;
- b. A short plain statement of the claim showing that the pleader is entitled to relief; and
- c. A demand for judgment for the relief that the plaintiff deems entitled. (State the amount of money or property you believe you are owed plus interest).

Upon receipt of a civil complaint, the clerk of court establishes (or reestablishes) a case file.

Copies: Original forms are stored in the court case file.
A copy remains with the plaintiff
A copy remains with the defendant.

Cost: There is a \$25.00 filing fee for the civil complaint.
There is also a \$25.00 process service fee that must be paid for at the time of filing.
